# The following conditions will apply the Monday after 70% percent of NSW adults are fully vaccinated (From Monday, 11 October 2021)

Patrons/staff/contractors can only access the clubs if they are fully vaccinated or medically exempt. The 4sqm rule will apply in indoor areas with the 2sqm rule applying in outdoor areas (excluding outdoor gaming)

Standing while drinking is only permitted in outdoor areas

Up to 100 guests can attend weddings, with dancing permitted and eating and drinking only while seated

Up to 100 guests can attend funerals, with eating and drinking while seated

Masks will be mandatory in all indoor areas, and for customer-facing staff in outdoor areas

## The following conditions will apply the Monday after 80% per cent of NSW adults are fully vaccinated

All staff and customers must have received two doses of a COVID-19 vaccine or have a medical exemption

The 4sqm rule will apply in indoor areas with the 2sqm rule applying in outdoor areas (excluding outdoor gaming)

Standing while drinking is permitted in both indoor and outdoor areas

Group bookings (bistro) will be limited to a maximum 20 people (2 x groups of 10)

Capacity of weddings to be determined by the 4sqm rule with no upper cap, with dancing permitted and drinking while standing permitted.

Capacity of wakes to be determined by the 4sqm rule with no upper cap.

Masks will be mandatory in all indoor areas, and for customer-facing staff in outdoor areas

## The following conditions will apply to clubs across NSW from 1 December regardless of vaccination status

There are no restrictions or limitations for unvaccinated staff or customers

The 2sqm rule applies in indoor and outdoor areas

Standing while drinking is permitted in both indoor and outdoor areas

Capacity of weddings to be determined by the 2sqm rule with no upper cap, with dancing permitted and drinking while standing permitted

Capacity of wakes to be determined by the 2sqm rule with no upper cap

Masks will be mandatory for customer-facing staff

The NSW Government is working with Service NSW on the "vaccine passport", which will give the clubs and patrons an avenue to verify their vaccination status.

Before the "vaccine passport" is available, clubs must verify a patron's vaccination status using other means.

#### Where can I access my proof of vaccination?

You can access your proof of vaccination (COVID-19 digital certificate or immunisation history statement) using the attached information sheet

#### Can I come to the club if I've only had one vaccine dose?

The NSW Government has announced that only people who have received both doses of the vaccine can come to the club the Monday after NSW reaches the 70 per cent double-dose milestone.

### What if I can't get vaccinated?

Subject to the legislation which mandates vaccinations, people who can't be vaccinated may be permitted to enter the club if they obtain a "contraindication certificate" in the approved form (<a href="https://www.health.nsw.gov.au/Infectious/covid-19/vaccine/Documents/covid-19-vaccine-contraindication.pdf">https://www.health.nsw.gov.au/Infectious/covid-19/vaccine/Documents/covid-19-vaccine-contraindication.pdf</a> ). Please consult your medical practitioner for further information. It is likely that we will only be permitted to accept a medical exemption in the approved form.

How will the club know my proof of vaccine or medical exemption is authentic?

At the Clubs discretion, we may attempt to verify that your "proof of vaccine" is authentic. We remind you that it is a federal offence to falsify this information.
